You shall give not less than 14 working days' notice of your intention to terminate the agreement and we reserve the right to terminate immediately for breach of Agreement, conduct damaging our reputation, or failure to pass a background check.

CONFIDENTIALITY

You agree to keep our confidential information secret, including client lists and marketing strategies. This obligation continues even after the Agreement ends.

COMPLIANCE

You agree to follow all applicable laws while promoting Equipmentshare.ng.

INDEMNIFICATION

You agree to indemnify, defend, and hold harmless Equipmentshare.ng, its affiliates, and their respective officers, directors, employees, agents, and assigns from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to your breach of this Agreement, your violation of any law, or your negligent or wrongful acts.

Nigerian law applies to this Agreement.

DISPUTE RESOLUTION
